#### A. Terms of Service for Authors

These Terms of Service ("Terms") govern your use of the eAcademicBooks website, platform, and related services (collectively, the "Site") as an author or content provider. By creating an account, uploading content, or otherwise publishing through the Site, you agree to be bound by these Terms. If you do not agree, you may not use the Site to publish works.

# 1. Applicability of Publishing Agreement

## **Contractual Relationship**

If you have signed a separate publishing agreement with eAcademicBooks LLC ("we," "us," "our"), that agreement is the primary document governing your relationship with us. These Terms apply in addition to, and do not replace, the terms of your signed agreement.

If you publish content through the Site without a separate signed publishing agreement, your use of the Site to publish constitutes your acceptance of, and agreement to be bound by, the eAcademicBooks Standard Publishing Agreement ("Publishing Agreement"), which is incorporated into these Terms by reference. A current copy of the Publishing Agreement is available on our site and may be updated from time to time. ### **Pre-Existing Agreements**

If you have a pre-existing written distribution or publishing agreement with eAcademicBooks that does not contain the duties, representations, and warranties set forth in the current Publishing Agreement, the royalty provisions of your pre-existing agreement will continue to govern. However, by continuing to use the Site to publish, distribute, or sell your work, you agree to be bound by all other duties, obligations, and protections described in these Terms and the current Publishing Agreement, which are hereby incorporated by reference, regardless of whether your original agreement expressly included them.

In all cases, if there is a conflict between these Terms and the Publishing Agreement, the Publishing Agreement will control with respect to publishing matters.

## 2. No Agency Relationship and Course Adoption

Authors publishing through eAcademicBooks are independent contractors and are not employees, agents, partners, or joint venturers of eAcademicBooks. Nothing in these Terms or any associated Publishing Agreement shall be construed to create any employment, agency, partnership, or joint venture relationship. Authors have no authority to bind or obligate eAcademicBooks in any manner.

The decision to adopt, assign, or otherwise require any work in an academic course or program rests solely with the author and their affiliated institution. eAcademicBooks does not require, incentivize, or encourage such adoption, and any such adoption is made independently by the author in accordance with their institution's policies and applicable laws.

### 3. Author Responsibilities

## 4. Account Security

You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account. You agree to

notify us immediately of any unauthorized use of your account. You may not share your account credentials with others.

## 5. Acceptable Use

You may use the Site only for lawful purposes and in accordance with these Terms. You agree not to:

- Use the Site in any way that violates applicable laws or regulations.
- Post or transmit any infringing, defamatory, obscene, or otherwise unlawful content.
- Interfere with or disrupt the operation of the Site.
- Attempt to gain unauthorized access to the Site, other accounts, or our systems.

### 6. Intellectual Property

Authors retain ownership of your content subject to the license and rights granted to eAcademicBooks in the Publishing Agreement. Authors grant us the rights necessary to publish, distribute, and promote your work in accordance with that agreement.

To the maximum extent permitted by law, we are not liable for indirect, incidental, special, consequential, or punitive damages arising from your use of the Site or your publishing activities.

## 9. Changes to These Terms

We may update these Terms from time to time by posting the revised version on the Site. Continued use of the Site after changes are posted constitutes acceptance of the new Terms.

# 10. Governing Law

These Terms are governed by the laws of the State of Indiana, without regard to its conflict-of-law rules. Any disputes shall be resolved exclusively in the state or federal courts located in Benton County or Tippecanoe County, Indiana.

#### **B.** Terms of Service for Customers/Students

These Terms of Service ("Terms") govern your access to and use of the eAcademicBooks LLC website, applications, and related services ("Services"). By accessing or using our Services, you agree to be bound by these Terms.

## 1. Eligibility

You must be at least 18 years of age, or have legal parental/guardian consent, to use our Services.

## 2. Account Registration

### 3. Purchases and Access

#### a. Purchase Grants License

### c. Name/Email Change Policy

You may request a change to the name or email address associated with a book license within **14 calendar days** of purchase. No changes will be processed after this period.

### 4. Refunds and Disputes

Refund requests will be considered within a reasonable period after purchase and must be initiated by contacting **support**@eAcademicBooks.com. Initiating a chargeback without

contacting support first is prohibited and may result in immediate loss of access and refusal of future service.

#### 5. Prohibited Conduct

You may not:

- a. Use any service or content provided by eAcademicBooks LLC for unlawful purposes;
- b. Share login credentials or Unique Book Serial Numbers (License Codes);
- c. Attempt to bypass, disable, or circumvent security measures;
